#### Dr. Watkins was featured on ABC15.

This format allows students to demonstrate their knowledge and understanding of constitutional principles. Our students did very well in their last event before the break, received praise from the program's leaders, and are ready to go to the next event. Background: We the People is sponsored by the Arizona Bar Association to promote student's competence in civics, the understanding of the institutions of American constitutional democracy, and the contemporary relevance of the Constitution and Bill of Rights.

#### Paseo Pointe Posadas.

Paseo Pointe Dual Language Academy hosted its annual Posadas at the Pointe event on December 20. Structured in the spirit of the centuries-old Las Posadas tradition in Mexico in which people participate in festivities at a family's home for nine nights in December, Paseo offered nine activities; such as crafts, games, and student performances for families to participate in across the campus. Well over 1,000 people attended this year's event.

#### Parent Advisory Meeting.

The Superintendent held the second Parent Advisory meeting of the year just before the break. Topics included Jobs of the Future, one of our presentations tonight.

#### Parent/Teacher Conferences.

We are looking forward to our winter conferences with parents. Conferences will be taking place next week, with Thursday and Friday both being half-days of school, in order to allow teachers sufficient time to meet with parents. It is our goal to meet with every student's

parent/guardian during this second round of conferences. Teachers will be sharing and discussing important topics such as grades, NWEA and AIMSWEb data, attendance data, and will be establishing goals in collaboration with parents.

#### Mission Kindergarten.

We invite all prospective families of students entering kindergarten next year to join us for Mission: Kindergarten on February 5 from 5:00 - 6:30 at all Laveen schools.

#### VDS Career Day.

Vista del Sur Accelerated Academy held a career day for students in fifth through eighth grades just before the break. Over 20 professionals from a variety of industries hosted stations in which students could ask questions and learn about how their own skill sets could benefit them in each career field. Students chose three careers to focus on and had the opportunity to interview the professional using a questionnaire to help guide them. Professionals included a pilot for Frontier Airlines, a defense lawyer, medical field staff, and a school district superintendent.

### Legislative Session.

As of Monday, the Legislative Session is officially underway. We are carefully watching the education bills being introduced and will advocate for the best interests of the District.

#### Art Grant.

I am excited to announce that the District has been awarded the Arts Consumable Grant by the Arizona Department of Education. The grant provides \$187,000 in consumable supplies to be distributed across staff. Those teaching art, music, band, and drama as well as Grades Preschool-3 will each receive \$1,000. Grant funds can be used on art supplies, materials and instructional aids such as painting supplies, props for performances, sheet music, and ceramic supplies to name a few. We are excited about this opportunity and to continue supporting the Arts in Laveen!

#### Job Fair.

The Laveen School District is hosting a job fair for teachers interested in joining our team. The job fair will be held on January 25, 2024, from 4:30 p.m. to 6:00 p.m. at the Laveen Education Center, 5001 W. Dobbins. Participants will have the opportunity to meet with Laveen administrators, including school principals. On our consent agenda, we will have a recommendation for our referral incentive for teachers who refer and new teachers who is hired by the District.
